10. Any item found defective or not meeting the required specifications shall be replaced immediately by the vendor at no extra cost.
11. Payment will be released after satisfactory delivery and verification of all items.

PRICING CONDITIONS

DELIVERY SCHEDULE

1. Due to urgent match schedules and continuous tournaments, delivery of materials must be ensured timely.
2. Delayed delivery will not be accepted and may lead to cancellation of the order and forfeiture of future eligibility.
3. All supplies must be made in coordination with the Store In-Charge.

ELIGIBILITY CRITERIA

Vendors submitting quotations must meet the following requirements:

1. Must be a registered firm/entity dealing in sports materials.
2. Must have prior experience in supplying to sports associations, academies, or recognized sports institutions (documentary proof preferred).
3. Must supply only branded and original materials, local, duplicate, or unbranded items will not be accepted.
4. Must hold a valid GST registration and PAN.
5. Must not have been blacklisted by any government, semi-government, or sports organization. A declaration in this regard shall be submitted.
