

ORDERS OF V.S. SAMPATH, I.A.S. RETD., ELECTROL OFFICER, HYDERBAD
CRICKET ASSCIATION - 2023

The Writ Petitioner Cricket Club had prayed before the Hon`ble High Court to suspend the Orders Dated 31.07.2023. passed by respondent No.3 in the Writ Petition, namely the Single Member Committee, Justice L. Nageswar Rao, in so far as barring the petitioner Club and its Executive Committee Members from holding office in Respondent No.1 (Hyderabad Cricket Association) and/or contesting elections in Hyderabad Cricket Association, pending disposal of Writ Petition No.23334 of 2023 on the file of the High Court.

The Hon`ble High Court after hearing the parties concerned, directed the Electoral Officer Hyderabad Cricket Association to examine the claim of the petitioner in accordance with Rule 33(3) of The Hyderabad Cricket Association Rules and Regulations 2018 and pass appropriate orders on the Representation dated 29.08.2023, submitted by Petitioner.

In the Interregnum the Hon`ble Supreme Court was seized of the matter on an application filed on behalf of Single Member Committee and passed Orders/directions in I.A. No. 183293/2023 Dated 15.09.2023 as follows.

"It appears that contrary to the intent of our order to put an end to the mess which was going on, in the process of working of the Single Member Committee and in appointing one Mr. Sampath Kumar to assist him in the election process, various parties have been approaching the High Court and seeking different orders. Some proceedings have also been filed before the District Courts.

In our view, no such proceedings could have been initiated at all and if they have any grievance, the only remedy lays before this court.

The result of the aforesaid is that we restrain the High Court and the District Courts from passing any order qua the working of the Single Member Committee and if orders have been passed, the same will not be given effect to."

In the Light of the above Orders/Directions of the Hon'ble Supreme Court, the representation dated 29.08.2023 does not survive and accordingly the representation stands disposed of.
